Both of these bedrooms are ample in size, with large windows and walk-in closets. All of the bedrooms are accessed from a central hall area with extra closet space. The hall overlooks the house's main foyer area with its cathedral ceiling and second-story bay window that has a built-in ledge for a deco-

The first floor, which has hardwood floors and nine-foot ceilings throughout, is built in three front-to-back connected areas. The most open of these is the family room, which has a gas fireplace toward the front end and extends to a large, concrete back porch partially covered by the upstairs deck, which is supported by attractive white columns. A nice touch is that the entry to this area from the central hall is an arched portal with an open, arched window-like space on either side that enhances flow and openness.

On the other side of the first floor is the kitchen and dining area, which aren't separated by a wall. Rather, there's a hint of separation created by the beginnings of a portal that extend just a short distance at the border of the two rooms. Above is a tiered ceiling, another rare touch. In effect, it is like a tray ceiling within a tray ceiling, a double inset that has a great aesthetic feel.

Kitchens have made a transition from utilitarian cooking areas to centers of household social commerce, and this one is no exception. Beautiful Maple cabinetry with cherry finish includes a wine rack, pullout drawers, a glass-door pantry, and ceramic tile backsplashes. Lighting is also provided both above and below the voluminous cabinets. In the center of the kitchen is an island with granite counter, fairly common in new homes, but this one includes the sink, attractively inset in a soft, double-rounded shape.

From the kitchen, a second stairway heads up over the garage to create a spacious inlaw suite with another full bathroom. Below is a two-car garage, so the room is very spacious, including a slightly elevated area that could serve as an office, breakfast nook, or entertainment area. It's a nice, private area not connected to the rest of the second floor, and with its own access to the kitchen provides a great second living space.
